A copy of the Notice of Sale must be delivered with the Livestock Manifest used to transport the animal to the sale. See LIS “Transportation and Inspection of Cattle and Horses under the Animal Keepers Act” for instructions on how to complete the required Livestock Manifest. All horses must be accompanied with a completed CFIA Equine Information Document (EID).
