INSTRUCTIONS CHANGE OF INFORMATION OF INDIVIDUAL BRAND OWNER

This form must be submitted to Livestock Identification Services Ltd. (LIS) in order to change the information of an individual brand owner on record with the Brand Registry. All of the fields in this form must be completed before the change will be accepted by LIS. A separate form must be completed for each brand.

This form cannot be used to change the primary contact for multiple brands owners. To do that, please use the *Change of Primary Contact for Multiple Brand Owner* form.

Brand Design	This is the characters used in the brand. Please first print the form and then hand draw the brand design in the space provided. The design must match what appears on the Brand Certificate and in the Brand Registry. The brand design must be provided.
Brand Location	This is the location of the brand as noted on the Brand Certificate and in the Brand Registry. The location must be provided.
Brand Type	Check whether this is a cattle or horse brand.
Old information	Enter the old information for the brand owner.
New information	Enter the new information for the brand owner.
Date form signed	Enter the date the form is completed.
Name and signature of brand owner	Enter the full name of the brand owner. This form must be signed by the brand owner.

Fee: There is no fee for this change to the Brand Registry.
