INSTRUCTIONS CHANGE OF TRADE NAME OF INDIVIDUAL BRAND OWNER

This form must be submitted to Livestock Identification Services Ltd. (LIS) in order to for an individual to change his or her Trade Name. All of the fields in this form must be completed before the form will be accepted by LIS.

Name of individual brand owner	Enter the name of the brand owner on file with LIS operating under the Trade Name being changed.
Trade Name	Enter the Trade Name on record with LIS.
Brand Design	This is the characters used in the brand. Please first print the form and then hand draw the brand design in the space provided. The design must match what appears on the Brand Certificate and in the Brand Registry. The brand design must be provided.
Brand Location	This is the location of the brand as noted on the Brand Certificate and in the Brand Registry. The location must be provided.
Brand Type	Check whether this is a cattle or horse brand.
Date of name change	Enter the date the Trade Name was changed.
Proof of Name Change	A replacement Trade Name Declaration must be filed with Corporate Registry and a copy of the Proof of Filing of this Declaration must be provided with this form.
Date and signature	Enter the date the form is completed and sign the form.

Fee: There is a fee of \$26.50 for changing a Trade Name as a new Brand Certificate must be issued. Payment must be submitted with the form.
