CHANGE OF NAME FROM INDIVIDUAL TO TRADE NAME

This form must be submitted to Livestock Identification Services Ltd. (LIS) in order to change from an individual name to a trade name.

Brand owner information	Enter the name, address and contact information for the brand owner.
Brand Design	This is the characters used in the brand. Please first print the form and then hand draw the brand design in the space provided. The design must match what appears on the Brand Certificate and in the Brand Registry. The brand design must be provided.
Brand Location	This is the location of the brand as noted on the Brand Certificate and in the Brand Registry. The location must be provided.
Brand Type	Check whether this is a cattle or horse brand.
Proof of Trade Name	A Trade Name Declaration must be filed with Corporate Registry and a copy of the Proof of Filing of the Trade Name Declaration must be provided with this form.
Date form signed	Enter the date the form is completed.
Signatures	Sign the form and have your signature witnessed.

Fee: There is a fee of \$26.25 for changing to a trade name in the Brand Registry.
