INSTRUCTIONS CHANGE OF INFORMATION OF CORPORATE BRAND OWNER

This form must be submitted to Livestock Identification Services Ltd. (LIS) in order to change the corporation's information on record with the Brand Registry. All of the fields in this form must be completed before the change will be accepted by LIS. A separate form must be completed for each brand.

Corporate Brand Owner	Enter the full name of the corporate brand owner.
Brand Design	This is the characters used in the brand. Please first print the form and then hand draw the brand design in the space provided. The design must match what appears on the Brand Certificate and in the Brand Registry. The brand design must be provided.
Brand Location	This is the location of the brand as noted on the Brand Certificate and in the Brand Registry. The location must be provided.
Brand Type	Check whether this is a cattle or horse brand.
Old information	Enter the corporation's old information.
New information	Enter the corporation's new information.
Date form signed	Enter the date the form is completed.
Name(s) and signature(s) of signing officer(s)	Enter the full name(s) of the signing officer(s) on file with LIS. This form must be signed by the signing officer(s). If there are two signing officers, both must sign this form.

Note: If the person(s) completing this form is/are not on record with LIS as the signing officer(s) for the brand owner please also complete and return a copy of the Change of Signing Officers of Corporate Brand Owner form to be processed at the same time.
