This form must be submitted to Livestock Identification Services Ltd. (LIS) in order to change the name of a corporate brand owner. All of the fields in this form must be completed before the change will be accepted.

Signing officer of brand owner	Enter the name of the signing officer on file with LIS. Note: If the person completing this form is not on record with LIS as one of the signing officers for the corporate brand owner please also complete and return a copy of the <i>Change of Signing Officers of Corporate Brand Owner</i> form to be processed at the same time.
Name of Brand Owner	Enter the full name of the brand owner
Brand Design	This is the characters used in the brand. Please first print the form and then hand draw the brand design in the space provided. The design must match what appears on the Brand Certificate and in the Brand Registry. The brand design must be provided.
Brand Location	This is the location of the brand as noted on the Brand Certificate and in the Brand Registry. The location must be provided.
Brand Type	Check whether this is a cattle or horse brand.
Proof of Name Change	The change of name must first be done through Corporate Registry. A copy of the Certificate of Amendment issued by Corporate Registry must be provided with this form.
Date form signed	Enter the date the form is completed.
Signature of signing officer	The signing officer whose name appears at the top of the form must sign the form.

Fee: There is a fee of \$26.50 for changing the name of a corporation as a new Brand Certificate must be issued. Payment must be submitted with the form.
